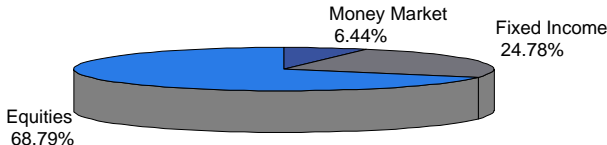

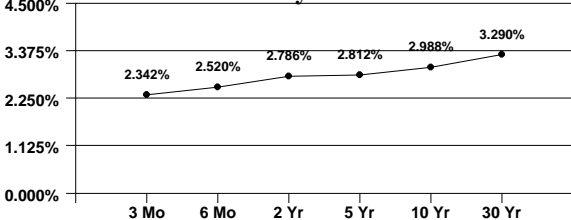
Asset Allocation
